Childhood Immunization Status (CIS)



What is the measure?

CIS assesses the percentage of children who have had the appropriate number of each of the vaccinations four (4) diphtheria, tetanus and acellular (**Dtap**); three (3) polio (**IPV**); one (1) measles, mumps, and rubella (**MMR**); three (3) hemophilus influenza type B (**Hib**); three (3) hepatitis B (**Hep B**); one (1) chicken pox (**VZV**); four (4) pneumococcal conjugate (**PCV**); one (1) hepatitis A (**Hep A**); two (2) or three (3) rotavirus (**RV**); and two (2) influenza (**Flu**) on or before the child's **second birthday**.

Why is this measure important?

Vaccination is one of the best ways parents can protect infants, children and teens from potentially harmful diseases. Vaccine-preventable diseases can be very serious, may require hospitalization, or even be deadly - especially in infants and young children.

How can I improve my HEDIS scores?

Document the member's immunizations. Include appropriate diagnosis to indicate that these services were rendered. Utilize tools provided through AvMed's [Pediatric & Adolescent Provider Matrix](#)

Helpful Hints for Your Practice

- Document all components of this measure at correct dosages per vaccination before child's 2nd birthday and include appropriate codes on the claim.
- Using a vaccination sheet document the appropriate vaccinations with type of vaccination, vaccine #1, 2 etc. that meets the standard for this measure.
- Enter vaccination information into Florida Shots at www.flshots.com.
- Submit medical record to AvMed, if requested.

If the member already had vaccine(s), or has had an anaphylactic or other adverse reaction to a vaccine, document the date(s). Submit medical record with notation of vaccines to AvMed when requested.
